Source of Water: BLACKHAWK COLLEGE EAST CAMPUSBased on information obtained in a Well Site Survey conducted in 2003 by the Illinois Rural Water Association for the Illinois EPA, several potential sources are located within 1,500 feet of the wells. The Illinois EPA has determined that the Black Hawk College - East Campus Community Water Supply's source water is not susceptible to contamination. This determination is based on a number of criteria including; monitoring conducted at the wells; monitoring conducted at the entry point to the distribution system; and available hydro geologic data on the wells.

#### Lead and Copper

Maximum Contaminant Level or MCL:	The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
Maximum Contaminant Level Goal or MCLG	: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
Maximum residual disinfectant level or MRDL:	The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
Maximum residual disinfectant level goa or MRDLG:	al The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
